(1) Deponent is of legal age and resides at _____

(4) If deponent should find or recover the original, deponent will immediately surrender the same to the corporation for cancellation without requiring consideration therefore.

(5) The deponent agrees at all times to indemnify and save harmless **Yak-Tat Kwaan, Inc.** Corporation and its Transfer agents and Registrars and each of them, their respective legal representatives, successors and assigns (hereinafter collectively called the "Obligees"), their successors or assigns, from and against any and all liabilities, losses, damages, judgments, costs, charges, counsel fees and other expenses of every nature and character, which the Obligees or any of them may sustain by reason of the replacement of the lost certificate above described and payment of all unpaid dividends and other accruals, if any.
